- 2. The request must be made in writing and be accompanied by any necessary information/documentation to identify the enquirer (for example NRIC/ Passport no., student ID or other form of proof of identity) and to locate the record of personal data to be corrected.
- The Singapore Institute of Technology ("SIT") will comply with the request for correction within 30 days of receiving the request or receiving the required information, whichever is later. SIT will provide an updated timeline should SIT require more time to respond to the correction request.
- 4. Please complete the following form and sign the accompanying declaration and submit, with your proof of identity, to the Data Protection Officer at the address given below.
- 5. SIT is not required to correct Personal Data for:
  - a. Opinion data kept solely for an evaluative purpose;
  - b. Any examination, examination scripts and, prior to the release of examination results, examination results; or
  - c. Document related to a prosecution if all proceedings related to the prosecution have not been completed.
- 6. SIT may send the corrected personal data to specific organisations to which the personal data was disclosed by SIT within a year before the date the correction is made.
